Made contact with [redacted] the mother of [redacted] [redacted] explained at the beginning of each week she separates 7 days worth of [redacted] medications for [redacted] which include [redacted] [redacted] medication. There are 28 pills for each week. Prior to my arrival she stopped at her [redacted] apartment to check [redacted] well being to discover all the pills missing. I spoke with [redacted] who appeared somewhat disoriented. [redacted] stated [redacted] may have ingested the pills but could not remember. [redacted] stated [redacted] was not having any thoughts of harming [redacted] and has not been depressed. If [redacted] did ingest the pills [redacted] is unsure why. [redacted] was transported to CMC to receive medical attention due to the possibility of an accidental overdose. - 359
