Narrative Toms River Police Department Investigation Narrative Incident: Terroristic Threats Location: Crowder Drive Date: 08/31/2018 Victims/Parent/Guardians: Arrested: (JV) On 8/31/2018, several TRPD units and myself responded to Crowder Drive in reference to a civil matter, with a potential firearm. While en route, dispatch (JV) was inside the home, and had threatened advised the suspect, to use a firearm on his stepfather, Prior to arrival, was awaiting our arrival left the residence, and his wife, was contacted by dispatch and advised to walk outside. Upon arrival, over to my location for safety. advised her had threatened both and her with a firearm. They left the home, but was still inside alone. At that time, more officers arrived on scene, and a perimeter was established. As officers approached the home, began to walk out of the front door of the home, and he was commanded to keep his hands in the air. followed all commands given by officers, and was placed under arrest at that time. I spoke with who stated, was agitated about a prior charge he had recently received, and began taking it out on her. As he was yelling at her, he grabbed two kitchen knives and was threatening to use them. He eventually put the knives down, and was able to take them. At that time, stepped in, and yelled at for talking to his mom in that manner. became even more infuriated, and yelled at "I'll get my gun". When confronted about having a firearm, responded, "This is 2018, we don't fight, we shoot". Then threatened to retrieve his firearm, and shoot his stepfather. It is to be noted, is a member of the his parents are aware of. _____ then ran into his room and began digging around for a firearm. legitimately believed would act on his threat, therefore he left the home, and contacted this agency. was transported to District One for processing by Ptl. Devecka without incident, and he was placed in JV cell 1. A Juvenile cell log was generated by the jail's booking officers, and is attached to this report. He was charged with Terroristic Threats on a Juvenile Complaint (2C:12-3(b)). advised officers that is currently on probation, and provided documentation of that status. Ocean County Juvenile Intake was contacted and requested to take custody of

Ocean County Juvenile Intake was contacted and requested to take custody of based on this incident and his probation status. After contacting intake, they deemed did not qualify for Juvenile Detention. It took 1-2 hours to receive this determination from intake. mother was contacted to pick him up, but refused to pick him up, or allow him to go to with any other

relative. Therefore DCP&P was contacted. I spoke with employee ID 1504, and advised her of the incident. She advised a DCP&P representative would be responding to this agency shortly.

After 2-3 hours, Ashley from DCP&P responded to District One to speak with Next, she responded to residence to speak with her to help come up with a solution. As all other options were exhausted, at the time of this report, DCP&P is still at Crowder Drive attempting to come to a solution with Nothing further at this time.
