Narrative

1. Operation of the Motor Vehicle: 8/18/2018

On this date, I was assigned to a DWI checkpoint and was on a dismounted post in a parking lot in the area of State Highway 37 and Douglas, Toms River. The above vehicle, a Gray Hyundai bearing NJ registration entered my zone of the checkpoint for further investigation.

2. When Stopped or Arrival at Scene:

I approached the vehicle on the drivers side and observed a white female operator, Waad Alghamdi. While speaking with the driver, I detected the odor of burnt marijuana emanating from within the vehicle. While speaking with Alghamdi she was moving around a lot in her vehicle looking for her registration, and I observed her hands to be trembling. I asked Alghamdi if she was a Medical Marijuana patient, to which she stated that she is not. As Alghamdi searched for her license, I observed her hands to be shaking and she fumbled with her documents. Additionally, while speaking with Alghamdi I observed her speech to be excited and loud. Her eyes were bloodshot and watery and her pupils were dilated. At that time, I advised the driver to exit her vehicle to perform SFST's.

WALK AND TURN

I advised the driver that I would explain and demonstrate the test and not to begin the test until I instructed to do so. The driver was instructed to get into the starting position by placing her right foot in front of his left foot with the heel of her right foot, touching the toe of her left foot. It took the driver multiple attempts to get into the correct heel to toe starting position. The driver was then instructed to keep her hands down to her side and take nine heel to toe steps forward counting each step out loud and then take a series of small steps toward the direction she just walked from and perform the test in the same manner. The driver started the test early, never maintained heel to toe contact and raised her hands for balance. The driver was unable to successfully complete this test.

ONE LEG STAND

The driver was instructed to get into the starting position by placing her feet together and arms down to her side. She was instructed to lift either foot she preferred, six inches off the ground and to count aloud, one one thousand, two one thousand, three one thousand, and so on until I instructed her to stop. I asked the driver if she understood the instructions and she replied "yes". The driver was swaying side to side and raising her arms for balance. Same was unable to successfully complete this test. The driver was arrested for DWI and odor of marijuana. Same was handcuffed, read her Miranda rights, and searched with negative results and secured in the rear of my Troop car. Alghamdi stated at this time "I smoked earlier." Both passengers were taken into custody without incident and secured in the rear of the Troop car.

A PC search of the vehicle was conducted and met with positive results, specifically (1) one plastic bag containing suspected CDS Marijuana, (1) one black smoking pimp, (1) one clear plastic bag containing suspected CDS crack cocaine, found in the back seat of the vehicle. Alghamdi was transported to Toms River PD for processing. The vehicle was impounded, reference John's Law. Passengers was transported to Toms River PD for processing..

3. En Route to Station or Other Location:

The odor of burnt marijuana was detected in the vehicle, same was not present prior to securing Alghamdi in the rear of the Troop car.

4. At the Station or Other Location:

Once at Toms River PD, the driver signed her Miranda card. The driver was read paragraph 36 which he replied "Yes." I removed all cell phones and portable radios from the processing area and then completed the Drinking Driver Questionnaire. After the twenty minute observation period had passed without incident, the driver provided two valid samples with a new and separate mouth piece for each sample into the Alcotest. I administered the test and obtained a reading of .00% for these samples. Due to Alghamdi level of impairment being inconsistent with the Alcotest reading, a urine sample was requested and declined. Alghamdi was charged with DWI and released. The driver was released to Anna Cantillo, same signed the Potential Liability Warning.

Narrative

1. Operation of the Motor Vehicle:

On this date, the undersigned was assigned to assist with a DUI Check Point on SH-37 at Douglas St. A white Jeep Grand Cherokee bearing NJ registration entered the DWI Checkpoint. The vehicle was a random vehicle that entered the checkpoint and the odor of an alcoholic beverage was detected emanating from interior of the vehicle. The driver was ordered to pull into the Pisces Seafood parking lot, at the intersection of SH-37 and Douglas Street where I initiated a motor vehicle stop.

2. When Stopped or Arrival at Scene:

Upon approach of the vehicle I spoke with the driver, later identified as William Thompson, and requested all proper documentation. I immediately detected the odor of an alcoholic beverage emanating from the interior of the vehicle. I asked Thompson how many drinks he had and he stated, "One or Two." Thompson's speech was slurred and slow. I then instructed Thompson to exit the vehicle to perform standardized field sobriety tests.

Before administering the tests, a check of the area revealed it to be level and free of debris. The area the tests were conducted was in front of Thompson's vehicle, same was illuminated by the vehicle's headlights. The tests were demonstrated and administered by myself, and are as follows:

Horizontal Gaze and Nystagmus Test (explained): Thompson's pupils were of equal size, equal tracking and there was no resting nystagmus observed. I observed lack of smooth pursuit in both eyes, the onset of nystagmus at maximum deviation in both eyes, and nystagmus prior to 45 degrees in both eyes. During the test, Thompson was observed swaying in a circular motion.

Walk and Turn Test (explained and demonstrated):

Instruction Stage: Prior to performing the test, Thompson stated that he had no leg, or hip injuries. While explaining the test, I had Thompson stand in the starting position, same's feet broke apart during the instruction stage multiple times.

Walking Stage 1st Nine: Thompson was observed failing to touch heel to toe on steps 2,3,4,5,6,7 and 8.

Turn Stage: Thompson failed to turn correctly, specifically by spinning around on the balls of his feet.

Walking Stage 2nd Nine: Thompson was observed failing to touch heel to toe on steps 2,3,6, 7 and 8. Same raised his arms for balance the entire time.

One Leg Stand (explained and demonstrated): Thompson immediately raised his arms to maintain balance and put his foot down on count 5 and 6.

Thompson was then placed under arrest reference driving under the influence, searched for contraband with negative results, read his rights as per Miranda, and secured in the rear of Troop Car #163. A PC search for open containers was conducted and was met with negative results.

The above mentioned vehicle was subsequently TOT'd Toms River Police Department who handled securing the vehicle and impounding same reference John's Law.

3. En Route to Station or Other Location:

While enroute to Toms River Police Department, Thompson was quiet. The odor of an alcoholic beverage filled the interior of Troop Car #163.

4. At the Station or Other Location:

Upon arrival at Toms River Police Department, Thompson was again searched with negative results and secured in cell #5. Thompson was read his rights as per Miranda to which he acknowledged by signing a Miranda Card. I then read the Standard Statement for Operators of Motor Vehicles (39:4-50.2) to which Thompson replied "Yes". Same also completed the NJSP Drinking Driver/Operator Questionnaire. I observed Thompson without interruption for at least twenty minutes according to the time in the processing area and noted he did not regurgitate at any time. All police radios, DIVR transmitters, and cellular phones were removed from the processing area.

Narrative

I then administered the chemical breath test to Thompson by using Alcotest 7110 MKIII-C Serial Number ARAJ-0075, after a 20 minute observation period. I changed the plastic mouth piece after each sample. Thompson's breath test yielded a result of 0.22% BAC. Thompson was then charged with driving while intoxicated (39:4-50).

Thompson was released to his girlfriend, who signed the Potential Liability Warning (39:4-50.22), without incident. An initial court appearance in Toms River Municipal Court is scheduled for 08/27/2018 at 12:30PM.

Narrative

1. Operation of the Motor Vehicle:

On the above date, the listed vehicle was directed into a DWI checkpoint on SH-37 at Douglas Street in Toms River. Upon entering the designated area, I directed the driver to place the vehicle in park.

2. When Stopped or Arrival at Scene:

I approached the vehicle on the driver's side and attempted to make contact with the driver. I identified myself as a member of the New Jersey State Police and asked the driver, later identified as Thomas Leonard, to present his driver's license and vehicle paperwork. I immediately detected the odor of an alcoholic beverage emanating from the interior of the vehicle. Mr. Leonard began to shuffle through paperwork in his glove box and had a difficult time locating his identification. After a while, I instructed Mr. Leonard to remove his license from his wallet on his lap and present it to me. Mr. Leonard began to explain that he was only several blocks away from his residence. I detected the odor of an alcoholic beverage emanating from Mr. Leonard's breath as he spoke to me. I also found his eyes to be extremely bloodshot and watery. Mr. Leonard was asked how many drinks he consumed, to which he relied in effect "two beers and a burger". Mr. Leonard was asked to exit the vehicle in order to perform several standardized field sobriety tests to determine his ability to safely operate the vehicle. Mr. Leonard was escorted to an area where the ground was level and clear of any debris.

I first conducted Horizontal Gaze Nystagmus on Mr. Leonard. I found that Mr. Leonard had equal pupil size and equal tracking in both eyes. The test resulted in six "hits" out of a possible six. Mr. Leonard demonstrated a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and an onset of nystagmus prior to 45 degrees in both eyes.

Mr. Leonard was asked to perform the Walk and Turn test. Mr. Leonard was instructed to stand with his arms down at his side and with his right foot in front of his left foot, touching heel to toe. He was instructed to remain in that position while the test was explained to him and not to begin until instructed to do so. It was explained and demonstrated to Mr. Leonard that he was to take nine steps forward, touching heel to toe along an imaginary line as he took each step. He was further instructed to look at his feet while he took each step and keep his arms down at his sides while counting each step out loud. On the ninth step, he was instructed to keep his lead foot on the line, turn around slowly, and walk back in the same manner. While the test was explained to Mr. Leonard, he swayed back and forth as he stood and raised his arms from his side for balance. Mr. Leonard stepped out of the starting position and attempted to begin the test prior to instruction on several occasions. Mr. Leonard was placed back into the starting position, confirmed that he understood the instructions and began the test.

During this test, Mr. Leonard swayed back and forth while walking, and lifted his arms from his side for balance. Mr. Leonard missed touching heel to toe on all of his steps and stepped off of the line on several steps. Mr. Leonard did not take the correct number of steps and turned improperly. Mr. Leonard did not look down at his feet and proceeded to miss touching heel to toe all of his steps on the way back.

The next test Mr. Leonard was asked to perform was the One Leg Stand test. Mr. Leonard was asked to stand with his feet together and his arms down at his sides until instructed to move. It was explained and demonstrated to Mr. Leonard that he was to lift the leg of his choosing approximately six inches off the ground, point his foot parallel to the ground, look down at his toe, keep his arms down at his sides, and count aloud by the one-thousands until told to stop. Mr. Leonard acknowledged that he understood the instructions.

During this test, Mr. Leonard swayed from side to side and raised his arms from his side for balance. He placed his foot down on several occasions and could not maintain balance on one leg. Mr. Leonard terminated the test on his own

The tests were conducted on a smooth and flat surface free from debris. Based on the driver's performance of the standardized field sobriety tests, the strong odor of an alcoholic beverage on his breath, and his eyes being watery and bloodshot, Mr. Leonard was placed under arrest for operating a motor vehicle while under the influence of an intoxicating liquor and/or drug. He was handcuffed, searched (negative), and placed in the rear of the Troop Car.

The above mentioned vehicle was subsequently TOT'd to the Toms River Police Department. Toms River Police Department handled securing the vehicle and impounding same reference John's Law.

3. En Route to Station or Other Location:

The interior of the Troop Car filled with the odor of an alcoholic beverage that was not present prior to Mr. Leonard being placed in it.

4. At the Station or Other Location:

Mr. Leonard was escorted into the station and secured in the holding area. I advised the subject of his Miranda Rights

and provided a copy of same. The subject was provided a copy of the DMV Standard Statement for Operators of a Motor Vehicle. Mr. Leonard agreed to provide a sample of his breath for testing. Mr. Leonard was directly observed, uninterrupted for 20 minutes. Prior to administering the Alcotest, I removed all portable radios and cellular devices from the room. I administered the test utilizing Toms River PD Alcotest. The test resulted in a .18% BAC. Mr. Leonard was charged with DWI, and issued the proper summonses. He was TOT'd to Toms River PD reference CO-OP for John's Law procedures.

Narrative

1. Operation of the Motor Vehicle: August 19, 2018 (Sunday)

On this date, I was working a supplemental DUI enforcement detail (T540 / "Over the Limit, Under Arrest") in Toms River Township, Ocean County. The detail involved a stationary DUI checkpoint set up on the lot of Pisces Seafood, 3400 Route 37 East, Toms River, 08753. I was operating Troop car #883A, a marked patrol unit. The above listed motor vehicle, a 2016 gray in color Jeep Cherokee bearing New Jersey registration was stopped in the checkpoint; Troopers performing pre-screening of drivers directed the driver toward my position for further interaction.

2. When Stopped or Arrival at Scene:

I directed the driver of the Jeep Cherokee to stop on the parking lot and made contact with same. The driver, who was the vehicle's lone occupant, was identified as the vehicle's registered owner, Christopher E. Nowak. Immediately upon speaking with Nowak through the open driver's side window, I detected the odor of an alcoholic beverage emanating from the interior of the vehicle. In addition, Nowak's eyelids were drooping, and his eyes were watery and bloodshot. His speech was slightly slurred, slow, and deliberate. When asked where he was coming from and if he had consumed alcohol, Nowak advised he had been crabbing just over the Route 37 bridge and had consumed one(1) beer. At that time, I directed Nowak from the vehicle in order to perform Standardized Field Sobriety Tests (SFST).

Nowak was directed to an area between his vehicle and Pisces Seafood. The area was flat and free of debris. Lighting conditions consisted of several Troop cars' headlights, Nowak's vehicle's headlights, and my flashlight. Nowak was barefoot to perform the tests.

I began by performing Horizontal Gaze Nystagmus (HGN) testing on Nowak. I had to perform HGN testing on Nowak several times as he was unable to follow the stimulus. He displayed a lack of smooth pursuit in both eyes, as well as distinct and sustained nystagmus at maximum deviation in both eyes. Additionally, I observed the onset of nystagmus prior to 45 degrees in both of Nowak's eyes. It should also be noted that I observed Nowak to be swaying while standing still during the administration of HGN testing. While speaking with Nowak in the open air, the odor of an alcoholic beverage was detected on his breath.

Walk and Turn (explained and demonstrated):

-Instruction stage: Nowak was unable to maintain the starting position for the duration of the instruction period. When asked, he advised he would physically be able to complete the test. Nowak stated he understood my instructions and was advised to begin.

-Walking stage (first nine): Nowak walked forward as directed, stepped off line, and did not maintain heel to toe contact on several steps. He then performed an improper turn.

-Walking stage (second nine): Nowak did not maintain heel to toe contact on several steps and performed and incorrect number of steps (ten total).

One Leg Stand (explained and demonstrated):

-Nowak began by lifting his right foot and counted to "four one thousand" before placing his foot on the ground. He swayed in a circular manner while performing the test. He was reminded of my instructions to begin the test again and attempted to perform the test. He ultimately attempted the test two more times, successfully counting to "six one thousand" before stopping the test. At that time, the One Leg Stand test was terminated.

At that time, the SFST were completed. I asked if he could recite the English alphabet from the letter D as in "dog" to T as in "tree." When asked, Nowak advised he had a high school degree and spoke English as his primary language. Nowak was unable to successfully perform the test, slurring several letters together and misplacing many within the alphabet.

Due to the following observations, I made the determination that Nowak had been driving while intoxicated:

- -The observed physical signs of impairment, to include his watery and bloodshot eyes, and his slightly slurred, slow, and deliberate manner of speaking.
 - -His lack of coordination and performance of SFST.
 - -The odor of an alcoholic beverage emanating from his breath as Nowak spoke in the open air.
 - -His admission of having consumed alcohol prior to driving.

At that time, Nowak was placed under arrest, handcuffed, advised of his rights as per Miranda, searched (negative), and secured in the rear of Troop car #883A. A subsequent probable cause search of the interior of the vehicle was met with positive results for one(1) opened bottle of Heineken beer, which was located underneath the front passenger's seat. The vehicle was towed from the scene by the Toms River Police Department.

3. En Route to Station or Other Location:

While en route to the Toms River Police Department for processing, Nowak was quiet and cooperative.

4. At the Station or Other Location:

Upon arriving at the Toms River Police Department, Nowak was placed into a temporary holding cell. He was read the Attorney General's Standard Statement for Operators of a Motor Vehicle and replied that he would provide samples of his breath for the purpose of determining alcohol content. He was observed for twenty minutes, during which time he did not vomit, regurgitate, or place anything inside his mouth. During that period, a questionnaire was completed. Nowak advised again he had only consumed one(1) beer prior to driving. I operated the Alcotest machine and Nowak successfully provided two(2) adequate samples of his breath. The results indicated a "control test failure" and the tests were performed again. Nowak was again observed for twenty minutes, during which time he did not vomit, regurgitate, or place anything inside his mouth. He again provided two(2) adequate samples of his breath, the results of which indicated he had a .12% BAC. The results were entered into the Alcotest calculator and found to be a true and accurate calculation.

Nowak was charged on a hand written summons with 39:4-50 and additional offenses. He was ultimately released to the custody of his wife, Elizabeth Nowak, who signed a Potential Liability Warning Form (see attached). The vehicle was impounded by the Toms River Police Department in accordance with John's Law.

Narrative

1. Operation of the Motor Vehicle: 08/19/2018

On the above date at approximately 0125 hours, I conducted a motor vehicle stop during a mobile DWI checkpoint located at State Highway 37 / Douglas St., Toms River (Dover Twp.), Ocean Co.

2. When Stopped or Arrival at Scene:

I advised NJSP Communications (6 Comm) of my location and approached the vehicle. I identified myself to the driver and requested her license, registration, and insurance information. The driver, Lisa Kopischke, was observed to be talking low and with slurred speech. I also observed Ms. Kopischke to have signs of droopy eye lids, watery eyes, and a flush face.

While speaking with Ms. Kopischke, I detected the odor of an alcoholic beverage emanating from the interior of the vehicle and on her breath. Ms. Kopischke was asked if she had any alcoholic drinks and she replied "Yes." She further stated that she knows that should not have been driving. Ms. Kopischke was asked to exit her vehicle to perform Field Sobriety Tests. I advised Ms. Kopischke that I would explain and demonstrate a series of Field Sobriety Tests for her to complete in order to determine if she was fit to drive. Ms. Kopischke was moved onto the sidewalk to the left side of her vehicle, it was level and clear of any debris. The first test performed on Ms. Kopischke was explained and demonstrated, the Walk and Turn Test.

I asked Ms. Kopischke if she had any injuries that would prevent her from performing the test properly. She stated that she suffered from and may affect her balance because she was nervous. Ms. Kopischke was informed at that point and throughout the testing that if she required any medical attention to notify the undersigned. Ms. Kopischke began the Walk and Turn test, placed in the starting position with her right foot in front of her left, touching heel to toe. While being placed in the starting position Ms. Kopischke remained unbalanced, had to regain her balance on several occasions, and had to be reminded to not start the tests until she was instructed to do so. Ms. Kopischke began taking the first nine (9) steps forward. Each of the first nine (9) steps Ms. Kopischke feet did not touch heel to toe on three (3) occassions and her hands did not remain directly at her side. The second set of nine (9) steps her hands did not remain directly at her side and she was leaning for balance.

The second test performed on Ms. Kopischke was explained and demonstrated, the One Leg Stand Test. Ms. Kopischke began the One Leg Stand test, placed in the starting position with her hands at her side and standing feet together. While being placed in the starting position Ms. Kopischke again remained unbalanced. While performing the test she failed to remain looking down at her toes, keep her foot at least six (6) inches above the ground as instructed in the demonstration, and repeated the same numbers while counting.

Ms. Kopischke was placed under arrest for Driving While Intoxicated, handcuffed, searched, and read her rights as per Miranda. Search of her person yielded negative results and she was placed in the rear of Troop car 727A. A probable cause search of the vehicle was conducted for evidence of impairment. Search of the vehicle yielded negative results. Toms River PD was dispatched and arrived on scene to impound the Nissan reference John's Law.

3. En Route to Station or Other Location:

While enroute to the Toms River PD, Ms. Kopischke was transported in Troop car 727A which became filled with the odor of an alcoholic beverage that was not present prior to Ms. Kopischke being secured in the same.

4. At the Station or Other Location:

Once inside Toms River PD, I secured my weapon, radio, cell phone, and all transmission devices in a secured, separate location. Ms. Kopischke was again advised of her rights per Miranda and acknowledged same.

I read section (36): THE NEW JERSEY STATE POLICE DRINKING AND DRIVING REPORT STANDARD STATEMENT FOR OPERATORS OF A MOTOR VEHICLE. Ms. Kopischke was given section (36) in English to follow along, he replied, Yes". I conducted the twenty (20) minute direct observation period, Ms. Kopischke did not ingest or regurgitate anything. I administered the Alcotest 7110 MKIII-C, Serial # ARWF-0394. Ms. Kopischke provided two breath samples as requested and the reported breath test result was .16% blood alcohol content.

Narrative

Ms. Kopischke was processed and issued the appropriate motor vehicle summonses. Ms. Kopischke remained at Toms River PD until a family member arrived to acknowledge the Potential Liability Warning for Ms. Kopischke.

Narrative

1. Operation of the Motor Vehicle: August 19, 2018 (Sunday)

On this date, I was working a supplemental DUI enforcement detail (T540 / "Over the Limit, Under Arrest") in Toms River Township, Ocean County. The detail involved a stationary DUI checkpoint set up on the lot of Pisces Seafood, 3400 Route 37 East, Toms River, 08753. I was operating Troop car #754A, a marked patrol unit. The above listed motor vehicle, a 2008 white in color Chevrolet Express bearing New Jersey registration was stopped in the checkpoint; Troopers performing pre-screening of drivers directed the driver toward my position for further interaction.

2. When Stopped or Arrival at Scene:

I directed the driver of the vehicle to stop on the parking lot and made contact with same at the vehicle's driver side window. I then identified myself, informed the driver of the reason that he was being interacted with, and requested his driver's license, registration, and insurance. While retrieving the documents, the driver handed me his debit card. I then informed the driver that I had requested his driver's license, to which he responded "Oh fuck." I again asked for his license, registration, and insurance, all documents were provided identifying the driver as Mr. Joseph A. Guilbeau IV. While interacting with the driver I detected the odor of an alcoholic beverage emanating from the interior compartment of the vehicle. It should be noted I observed Mr. Guilbeau's eyelids to be droopy, and his eyes to be bloodshot and watery. Mr. Guilbeau's speech was slurred and slow. When questioned to where he was coming from, same stated to the effect that he had been working in Seaside Heights at a liquor store. I then removed Mr. Guilbeau from the vehicle in order to perform Standardized Field Sobriety Tests. Mr. Guilbeau was placed in front of his vehicle, in a well lit area, on flat ground free from debris.

The first divided attention test that was administered to Mr. Guilbeau, was reciting the English Alphabet from the letter "C" to the letter "W" without singing or humming the test. When asked if he was familiar with the English Alphabet, same replied "Well duh." Mr. Guilbeau then began stating and singing the test by stating "C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, U, V, W,X, Y, and Z, shoot I was supposed to stop at W" highlighting his apparent signs of intoxication.

The second divided attention test that was administered to Mr. Guilbeau, was counting backwards from the number "92" to the number "78". Mr. Guilbeau acknowledged he understood the exam and began the test by stating, "92, 91, 90, 89, 88, 87, 86, 85, 84, 83,which one, 84, 83, 82, 81, 80, 79, ..., 78, 77, 76, 75". Mr. Guilbeau again provided the response in a delayed manner, showing his apparent signs of intoxication.

The first test administered was the Walk-and-Turn Test. Mr. Guilbeau was advised that I would be explaining and demonstrating the sobriety test to him and that he was not to start the test until the directions were complete.Mr. Guilbeau stated he had a no injuries that would hinder the results of the test. I explained and demonstrated the test to him and he acknowledged that he did understand the test directions. While explaining the directions, Mr. Guilbeau was observed raising his arms and leaning over in order to maintain his balance. During the Walk-and-Turn Test, I was trained to observe Mr. Guilbeau's performance for eight clues, if two or more clues are observed, the subject fails the test. The clues are the following:

- Can't keep balance while listening to instructions
- Starts before instructions are finished
- Stops walking to steady self
- Doesn't touch heel-to-toe
- Loses balance while walking (steps off line)
- Uses arms to balance (raises arms over six inches)
- Loses balance on turn or turns incorrectly; and,
- Takes the wrong number of steps

During the test, Mr. Guilbeau failed to walk and touch heel-to-toe, walked off the line, stopped walking to steady himself, and leaned to maintain his balance. Mr. Guilbeau totaled five clues out of a possible eight on this Standardized Field Sobriety Test.

Narrative

The second test administered was the One-Leg-Stand Test. I advised Mr. Guilbeau that I would be explaining and demonstrating the sobriety test to him and he was not to start the test until the directions were complete. He acknowledged my opening statement and I proceeded to explain the test. During the One-Leg-Stand Test, I was trained to observe Mr. Guilbeau's performance for four clues, if two or more clues are observed, the subject fails the test. The clues are the following:

- Sways while balancing
- Uses arms to balance (raises arms over six inches)
- Hopping
- Puts foot down

When questioned if he understood the examination, Mr. Guilbeau stated "yeah." Mr. Guilbeau again stated that he had no injuries at this time. When advised to begin the test Mr. Guilbeau was observed leaning forward, swaying side to side, raising his arms for balance, and placing his right foot down. Mr. Guilbeau totaled three out of a possible four clues on this Standardized Field Sobriety Test.

Mr. Guilbeau was subsequently placed under arrest for Driving While Intoxicated. He was handcuffed, searched with negative results for contraband, advised of his rights as per Miranda, and secured in the rear of the Troop Car. Mr. Guilbeau's vehicle was impounded reference John's Law, by Toms River Police Department. A subsequent open container search of the vehicle yielded negative results. Mr. Guilbeau was transported to Toms River Police Department for processing and the Alcotest.

3. En Route to Station or Other Location:

While en route to the station, the odor of an alcoholic beverage emanated from the interior compartment of the vehicle that was not present prior to Mr. Guilbeau entering it.

4. At the Station or Other Location:

Mr. Guilbeau was placed in the Station's temporary holding cell where he was observed for 20 minutes. During the twenty minute period immediately preceding the administration of the Alcotest, Mr. Guilbeau did not ingest, regurgitate, or place anything in his mouth that may compromise the reliability of the test results. I then secured my portable radio, DIVR Mic box, and all cell phones in the other room. I read the MVC Standard Statement for Operators of a Motor Vehicle and asked Mr. Guilbeau if he would provide samples of his breath of which he stated, "Yes." Mr. Guilbeau provided two valid breath samples. A recorded breath test result of 0.17% BAC was achieved. Same was charged and released to held by Toms River Police Department until a ride was secured. Mr. Guilbeau was issued his respective summonses, advised of his court date, and given his proper paperwork without incident.

Narrative

1. Operation of the Motor Vehicle:

On this date, the undersigned was assigned to assist with a DUI Check Point on SH-37 at Douglas St. A silver Kia bearing entered the DWI Checkpoint. The vehicle was a random vehicle that entered the checkpoint and the odor of an alcoholic beverage was detected emanating from interior of the vehicle. The driver was ordered to pull into the Pisces Seafood parking lot, at the intersection of SH-37 and Douglas Street where I initiated a motor vehicle stop.

2. When Stopped or Arrival at Scene:

Upon approach of the vehicle I spoke with the driver, later identified as Jahnny Delvalle Delvalle, and requested all proper documentation. I immediately detected the odor of an alcoholic beverage emanating from the interior of the vehicle. I asked Delvalle how many drinks he had and he stated, "Two." Delvalle's speech was slurred and slow. I then instructed Delvalle to exit the vehicle to perform standardized field sobriety tests.

Before administering the tests, a check of the area revealed it to be level and free of debris. The area the tests were conducted was in front of Delvalle's vehicle, same was illuminated by the vehicle's headlights. The tests were demonstrated and administered by myself, and are as follows:

Walk and Turn Test (explained and demonstrated):

Instruction Stage: Prior to performing the test, Delvalle stated that he had no leg, or hip injuries. Delvalle stated he had but it did not prevent him from performing the test. While explaining the test, I had Delvalle stand in the starting position, same's feet broke apart during the instruction stage multiple times.

Walking Stage 1st Nine: Delvalle was observed failing to touch heel to toe on steps 2, 4, 5, 6, 7 and 8.

Turn Stage: Delvalle failed to turn correctly, specifically by stopping and waiting to be instructed to continue the exam.

Walking Stage 2nd Nine: Delvalle was observed failing to touch heel to toe on steps 3, 6, 7 and 8. Same raised his arms for balance the entire time.

One Leg Stand (explained and demonstrated): Delvalle immediately raised his arms to maintain balance and put his foot down on count 3. Devalle was intructed to continue the test and started the test from the beginning, again putting his foot down on count 3.

Delvalle was then placed under arrest reference driving under the influence, searched for contraband with negative results, read his rights as per Miranda, and secured in the rear of Troop Car #123A. A PC search for open containers was conducted and was met with negative results.

The above mentioned vehicle was subsequently TOT'd Toms River Police Department who handled securing the vehicle and impounding same reference John's Law.

3. En Route to Station or Other Location:

While enroute to Toms River Police Department, Delvalle was calm and quiet. The odor of an alcoholic beverage filled the interior of Troop Car #123A.

4. At the Station or Other Location:

Upon arrival at Toms River Police Department, Delvalle was again searched with negative results and secured in cell #16. Delvalle was read his rights as per Miranda to which he acknowledged by signing a Miranda Card. I then read the Standard Statement for Operators of Motor Vehicles (39:4-50.2) to which Delvalle replied "Yes". Same also completed the NJSP Drinking Driver/Operator Questionnaire. I observed Delvalle without interruption for at least twenty minutes according to the time in the processing area and noted he did not regurgitate at any time. All police radios, DIVR transmitters, and cellular phones were removed from the processing area.

I then administered the chemical breath test to Delvalle by using Alcotest 7110 MKIII-C Serial Number ARAJ-0075, after a 20 minute observation period. I changed the plastic mouth piece after each sample. Delvalle's breath test yielded a result of 0.07% BAC. Delvalle was then charged with driving while intoxicated (39:4-50).

Narrative

Delvalle was unable to secure his own transportation from Toms River Police Department and remained at Toms River Police Department for 12 hours where he was later released without incident. An initial court appearance in Toms River Municipal Court is scheduled for 09/11/2018 at 9:00AM.

1. Operation of the Motor Vehicle:

August 19, 2018 (Sunday)

On this date, I was working a supplemental DUI enforcement detail (T540 / "Over the Limit, Under Arrest") in Toms River Township, Ocean County. The detail involved a stationary DUI checkpoint set up on the lot of Pisces Seafood, 3400 Route 37 East, Toms River, 08753. I was operating Troop car #555A, a marked patrol unit. A 2008 Dodge bearing Colorado registration was stopped in the checkpoint; Troopers performing pre-screening of drivers directed the driver toward my position for further interaction

2. When Stopped or Arrival at Scene:

I directed the driver to stop in the parking lot and made contact with same. I spoke with the driver, who, was identified as Rashon Patterson. Immediately upon speaking with Patterson through the open driver's side window, I detected the odor of an alcoholic beverage emanating from the interior of the vehicle. Patterson's eyelids were drooping, and his eyes were watery and bloodshot. His speech was slightly slurred, slow, and deliberate. When asked where he was coming from and if he had consumed alcohol, Patterson advised he had been on the beach just over the bridge in Seaside but had nothing to drink. At that time, I directed Patterson from the vehicle in order to perform Standardized Field Sobriety Tests (SFST).

I asked Patterson to stand in front of his car so I could administer the Horizontal Gaze Nystagmus test. Patterson failed to follow my instructions and could not complete the test.

I then explained and demonstrated the Walk and Turn Test. The area in which the SFSTs were demonstrated and performed can be described as a blacktop parking lot free from debris. Patterson was asked to stand in the starting position by placing his right foot in front of his left as I explained the test. Patterson was instructed to take nine heel-to-toe steps turn around and take nine heel-to-toe steps back coming back and counting each step out loud. In the starting position Patterson kept moving his feet out to the side for balance. During the test, Patterson had trouble maintaining his balance and failed to touch his feet together. Patterson took ten steps and after his tenth step stopped the test and didn't know what to do next.

I then explained and later demonstrated the One Leg Stand Test. He was advised to stand on the leg of his choice with the opposite leg straight and his foot approximately six inches off the ground. Patterson had a sagging knee and placed his arms out for balance. Patterson continiously put his foot down and just stopped the test. I asked Patterson if he was done and he stated, "yes."

At this point, I determined that Patterson was unable to operate a motor vehicle safely and he was placed under arrest for DWI. Same was handcuffed and searched with negative results. Patterson was read his rights as per Miranda. Patterson was placed in the back of the Troop car. A PC search of the vehicle was positive for a open bottle of Brandy, that was half empty. Patterson was transported back to Toms River Police Department for processing

3. En Route to Station or Other Location:

While en route to the station the interior of the Troop Car filled with a strong odor of an alcoholic beverage that was not present prior.

4. At the Station or Other Location:

At Toms River PD, Patterson was read the DMV Standard Statement and consented to the taking of breath samples. Same was observed continuously, face to face, for twenty minutes by the undersigned. All radios, cell phones and other electronic devices were removed from the processing room. The undersigned entered the data for the Alcotest 7110 MK III-C Instrument at Toms River. Patterson Provided two good breath samples resulting in a reading of 0.15% B.A.C. Patterson was asked the questions on the Drinking Driver/Operator Questionnaire, which he refused to answer. Patterson was charged with 39:4-50 DWI for his BAC being over 0.08% (the legal limit). Same was TOT'd with Toms River Police. Patterson was staying in Toms River holding cell until 8:00 a.ma pending transportation to Ocean County Jail.
