Alternatively, you may file a complaint with the Government Records Council (GRC) by completing a Denial of Access Complaint form in accordance with N.J.S.A. 47:1A-6. You may contact the GRC at its toll-free information telephone line at (866) 850-0511, by regular mail at P.O. Box 819, Trenton, NJ 08625-0819, by e-mail at Government.Records@dca.nj.gov, or through the GRC website at www.state.nj.us/grc. The GRC can also respond to other questions about the OPRA law.
